Dear Parents/ Guardians,

Quality Education Fund e-Learning Funding Programme - Provision of Mobile Computer Devices

To support needy students in accessing e-learning, the school will join the QEF e-Learning Funding Programme to purchase suitable mobile computer devices for loan. Families in receipt of Comprehensive Social Security Assistance (CSSA) or full grant/half grant of the School Textbook Assistance Scheme (STAS) are eligible to benefit from the programme. The devices are estimated to be available for borrowing in January 2025.

During the three-year implementation period of the programme (Starting from December 2021), each eligible student will receive the subsidy for a mobile computer device once. When a student beneficiary transfers to another school after receiving funding, the beneficiary is required to return the original device to the school.

Eligible students who are joining the programme should return this slip with relevant documents (Eg, Certificate for Medical Waivers, Eligibility Certificate of Textbook Assistance Scheme. Documents should include student's name, HKID number and be valid on 31st Dec 2024.) to the school office on or before 22nd November 2024.

Students who are not joining the programme do **NOT** need to return the reply slip.

Note:

- **The devices are properties of the school.** Eligible students can borrow the device for three years. They are required to return the devices by request for maintenance and updates.
- Students should **report to school immediately and compensate** for any loss, stolen or damage of devices and accessories.

優質教育基金電子學習撥款計劃 — 提供流動電腦裝置計劃
